We are pleased to officially announce that OSARO Intl Sports Academy (OISA) Football Camp will reopen on Tuesday, 1st September 2026, marking the beginning of our preparations for the new football season and our 2027 football programmes.

As part of the reopening, OISA is inviting talented, disciplined and ambitious football players to participate in a **ONE-WEEK RESIDENTIAL TRIAL AND SCREENING PROGRAMME**.

This is an opportunity for players who believe in their ability and are serious about developing their football career to come forward and demonstrate their talent, discipline, character and commitment.

⚽ ONE-WEEK TRIAL & SCREENING

All invited applicants will participate in a **one-week assessment programme inside the OISA Football Camp**.

During this period, players will be assessed on:

- Technical football ability
- Tactical understanding
- Physical condition and fitness
- Discipline and attitude
- Teamwork and communication
- Character and behaviour
- Ability to learn and follow instructions
- Commitment and long-term development potential

Accommodation will be provided within the camp during the trial period. Players participating in the trial will be responsible for the cost of their own feeding during the one-week assessment.

17 ACADEMY-SPONSORED PLACES

At the conclusion of the trial, OISA intends to select:

15 OUTFIELD PLAYERS + 2 GOALKEEPERS

These 17 selected players will form part of the Academy's officially supported/sponsored player programme as we prepare for the 2027 season, competitions, scouting opportunities, friendly matches, development programmes and other football activities.

Selection will be based on ability, potential, discipline, character and the needs of the Academy — not simply reputation or previous club history.

🔍 PLAYER BACKGROUND & ELIGIBILITY VERIFICATION

Being selected during the football trial does not automatically complete admission into the sponsored programme.

Before final confirmation, OISA will conduct appropriate verification to establish that the selected player:

- Has provided truthful personal information.
- Is not bound by an undisclosed contract or registration with another club, academy or football organisation.
- Is legally and practically available to join OISA.
- Has the knowledge and consent of their parent/guardian or next of kin where applicable.
- Understands and accepts the responsibilities of becoming an OISA player.
- Is genuinely prepared to develop and represent the Academy.

Any false declaration or undisclosed contractual obligation may result in the withdrawal of the offer.

OPPORTUNITIES FOR OTHER PLAYERS

Not being selected among the 17 sponsored players does not necessarily mean that a player has failed the Academy assessment.

Other players who demonstrate sufficient ability and potential may be offered admission as regular OISA Academy Players, subject to the Academy's normal registration requirements, fees and programme costs.

APPLICATION FORM IS COMPULSORY

Every player wishing to participate must obtain the official OISA Player Trial & Camp Application Form.

The form must be:

PRINTED → COMPLETED → SIGNED → SUBMITTED BEFORE THE CAMP OPENING/SCREENING DATE.

Applications without the required player information, next-of-kin/parent/guardian details and necessary consent may not be accepted.

OISA may contact the player's parent, guardian or next of kin before admitting the player into the residential camp. This is an important safeguarding and accountability requirement.

No unidentified or improperly referenced player will be admitted into the residential camp.
